NOTICE OF PUBLIC COMMENT PERIOD AND HEARING ABOUT AN APPLICATION TO CONVERT UNITS AT THE CAMPELLO HIGH-RISE DEVELOPMENT TO PROJECT-BASED VOUCHERS THROUGH A DISPOSITION PROCESS UNDER SECTION 18 OF THE UNITED STATES HOUSING ACT OF 1937 (AS AMENDED). The Brockton Housing Authority (BHA) intends to submit a disposition application to the Department of Housing and Urban Development (HUD) under Section 18 of the United States Housing Act of 1937 (as amended) for the Campello High-Rise Development (“Campello”) at 1380 Main Street, Brockton MA. The BHA has concluded that based upon existing conditions that Campello is obsolete as to its physical condition and other factors, making it unsuitable for its intended purpose; and that regrettably no reasonable program of modification or public housing resource from HUD is available, including Rental Assistance Demonstration, to restore the development to its useful life, other than the Housing Choice Vouchers that may become available through the disposition process.
